- 5. Discussion/Action Items

- a. BP 5500- changes included adding language that addressed sexual harassment or harassment for race or religion. Suggested edits included the following: 1. d Add hyphen between "Shasta College" and "recognize". Also change justification on page four.
- b. BP 5530-The change to this policy included adding a note at bottom of policy. Eva suggested that that there should be a definition added as to what representation means for the student. There was some discussion of how representation should be described to the student. Final suggestion was to Insert "a person" after representation in line three.
- b 2 AP 5500- Written by senate originally, the only changes are as follows: There is a change in title to include a discipline officer. No changes recommended to the form. One error was noted in the form on the second page of the form, there is hard return after "dean" on last page, this need to be removed.
- b 3 AP 5530-Adding definitions and reference to Ed code section. Definition for student-"a person who is currently enrolled, previously enrolled, or has filed an application". The end of the latter part of the student definition starting with "A grievance by an applicant" should be moved under "Student Grievance Procedures". The sentence starting with "Remove former students will be limited" should be removed.
- c. Plenary Session: Iraja Siva-Das. There were 46 resolutions brought to the plenary session and 35 of those were passed. Iraja read the list of the resolution to us. One resolution that passed was similar to ours in that it "grandfathered" teachers that were already working for a district if the Minimum Qualifications changed. Iraja is also working with the head of the resolution committee to write a resolution about cell phone use in classrooms. The resolution is to ban cell phones from the classroom. Iraja also gave us some updates on other items discussed at the plenary session.
