## Agenda:

- 1. Meeting called to Order at 3:05 p.m.
- 2. Ray Nicholas moved approval of minutes from the 02/22/10 Meeting. Motion seconded by Terry B. Cathy mentioned that the minutes needed to list the deletions. Motion passed with the correction.
- 3. Opportunity for Public Comment-none
- 4. Reports
  - a. Report from the Senate President (Cathy Anderson) –Cathy reported on a conversation she had with Gary Lewis about the deletion of the research position. Over

the past week she has heard from many faculty who have concerns about the college not having a researcher. Areas of concern were relating to SLO reporting and collection, Program Review, Perkins funding and overall planning. Shelly spoke up and said that she too had expressed concern to Gary Lewis about Shasta College losing the Institutional Researcher position and the impact the loss of that position would have on the SLO data collection process. She was specifically concerned about the apparent lack of planning for a continued SLO data collection process. When she met with Gary Lewis today he explained that he had a "mystery" person in mind and that a meeting would be scheduled in two weeks with her, Bill Cochran, Catherine Jackson, and the "mystery" person. Gary also stated he had not yet spoken to the "mystery" person and that Bill Cochran had not yet been informed about the meeting. As a point of clarification, Cathy Anderson asked Shelly who used the term "mystery." She replied that Gary had repeatedly used the term in their meeting. Cathy encouraged anyone with concerns relating to this position to talk to Gary Lewis about them in hopes that he might change his mind.

- c. Report from SLO Committee (Shelly Presnell)- Shelly mentioned that Gary Lewis had paid her back for expenses she had incurred leaving snacks for everyone in the SLO workshop rooms on FLEX Day. Shelly also mentioned that about 50% of the faculty will be getting emails for not submitting SLO's for fall. Some of these notices were because faculty had failed to submit the SLO data and some would be due to errors when filling out the form.

## 5. Discussion/Action Items

- a. BP5005 First reading-Cathy asked that ECE and Equipment Ops look at this before second reading.
- b. AP 5005-First reading- Cathy asked if the website listed was the correct website. The Suggestion was to just end website with "edu".
- c. BP5070-First reading. No suggestions for changes.
- d. AP5070- First reading. Cathy was not clear on AP5070 and the sentence following the introductory sentence. After some discussion it was suggested that it needed to be sent back for a rewrite.
- e. BP5075-First reading. No suggestions for changes.

Bill said that the way things are currently could cause problems as the College could be caught in the middle between state law and an accreditation.
