PROGRAM DESCRIPTION: This program initiates a systemic and scholarly study of the politics of influence, human behavior that shape world events. Through this curriculum students are exposed to research methodology that connects them to a formal operational level of reasoning. Political science studies diversity in cultures, how power is exercised or resisted, and how nations are governed. The Associate in Arts in Political Science for Transfer degree provides the student with the problem solving skills to become active participants in the world around them.

This degree is pending approval through the California Community College Chancellor's Office. Upon satisfactory completion of all degree requirements and filing an application for graduation with Admissions and Records, the student's transcript will reflect completion of this degree.

Upon successful completion of this degree, the student should be able to:

- 1. Demonstrate an understanding of the nature of political science, the origin and nature of the State, patterns and functions of government and how political ideologies affect open and closed systems of government today.
- 2. Describe basic structural components of national government (legislative, executive and judicial) and explain their relationship to each other and sub-national governmental units.
- 3. Describe and understand the Bill of Rights and the contemporary U.S. Supreme Court decisions, which explain the current status of individual rights as outlined by this document and later amendments.
- 4. Indicate the function of the mass media, particularly television and the internet, as a vital influence in the election process.
- 5. Identify and discuss how globalization has impacted the developing world.
- 6. Debate the issue of sustainability and potentially negative consequences of development.
- 7. Use critical thought to investigate the causes, costs and potential resolution of ethnic conflicts.
- 8. Discuss the history of and trends in the emergence of the international nation-state system and modern challenges to that system.
- 9. Synthesize knowledge of political, social and economic conditions in the world as evidenced through a research paper or project
- 10. Critically evaluate global political concepts such as balance of power, diplomacy, just war theory and arms control.

In addition to the 37-39 unit general education pattern for CSU or IGETC, students must complete the core courses listed below for the Associate in Science in Physics for Transfer Degree. Students must also obtain a minimum grade point average of 2.0 and a C or better in each major course. A "P" (Pass) grade is not an acceptable grade for courses in this major.

Term and Year of Previous Review: Fall 2017

Discuss any changes to the program as a result of the previous program review: We have increased the total number of students taking POLS classes across most demographic groups. Student success is higher in 2017-2018 than the five year average, with a 66% improvement. Retention rate is marginally higher as well, with an increase of 30%. AA-T in Political Science saw a 25% increase during the observed period. Political Science has no student populations of concern regarding student equity impact.

PROGRAM DATA ANALYSIS

Program Effectiveness: We have marginally increased the amount of degrees awarded, moving from 4 (2016-2017) to 5 (20172018).

Program Effectiveness (CTE): We have increased the amount of degrees awarded in this review period.

Course Success Rates: Student success is higher in 2017-2018 than the five year average, with a 66% improvement

Course Retention Rates: Retention rate saw an increase of 30% over the observed period.

Course Enrollments: Overall enrollment saw nearly a 10% increase in the observed period. Enrollment has increased every years since our Full Time Political Science Faculty member (Dr. David S. Pearl) was hired.

Equity: Equity population success is generally positive. Political Science has no student populations of concern regarding student equity impact.

CURRICULUM

Review of courses with prerequisites: Prerequisites are still viable, but should undergo reviews in the appropriate manner and within the appropriate time frame.

Challenges to offering key courses: I recommend adding a Comparative Politics class.

Course changes: We might consider changing the title of POLS 25 to: "Introduction to International Relations". We might add a Comparative Politics section as well.

SUMMARY

Changes or improvements needed based on the analysis above: Adding a Comparative Politics class would increase the amount of transferable units of our students.

Note any resources you intend to request through the Area Planning process to improve the program: None have been noted this observation.

Conclusion: The Political Science Program has excelled in a number of areas.
