| "Armed Forces of the United States" means the Air Force, Army, Coast Guard, Marine Corps, Navy, and the reserve components of each of those forces, the California National Guard, the California State Guard, and the California Naval Militia. * A former member of the Armed Forces of the United States who received a dishonorable or bad conduct discharge shall not be eligible for a non-resident tuition exemption. * For active duty military and their dependents, this exemption is valid as long as continuous enrollment is maintained even if the military member is transferred to a place outside this state as long as the member continues serve in the Armed Forces of the United States. * For discharged Veterans and their dependents, this exemption is valid for 1 year. | | | | |
