- 1. Meeting called to order by Mike Mari at 12:01 pm.
- 2. Review/Approval of Minutes
 - a. Susan motioned and Jim seconded to approve minutes from April 27, 2021 with Nadia abstaining. Minutes approved.
 - b. Leroy motioned and Jun seconded to approve minutes from October 12, 2021 with minor edits. The minutes were approved with Nadia, Lorelei and Desiree abstaining.
- 3. Committee member introductions: Committee members did introductions and welcomed Nadia to the committee.
- 4. Discussion: Bylaw Review
 - a. Current bylaws were adopted in 2013.
 - b. Suggested Edits:
 - i. Official membership could be scaled back from 13-15 to 9 voting members to include the following:
 - 2 Co-Chairs (1 Academic dean)
 - Minimum 5 Faculty representatives (Minimum 1 faculty from Counseling)
 - Minimum 1 Student Services staff
 - 1 Student Senate representative
 - ii. The committee will reach out to Student Senate to see if they have a representative that could attend the meetings.
 - iii. Bylaws will be evaluated each spring by the committee.

- iv. No term limits for co-chairs or members. With no maximums, we can allow additional members as they are interested. Instead of term limits, add language to bylaws regarding recruiting people to join committee.
- v. Current members will notify the committee prior to the May meeting if they would like to be replaced for an approaching academic year. The co-chairs will announce the vacancy to appropriate contingency group for appointment.
- c. If no Student Senate representative is appointed, the seat would remain open for a future representative.
- d. Review Committee Function: The committee has been doing their job as defined by our mission statement.
- e. The committee will look at docket for what's coming up this year, go through the process for this year and then revisit bylaw changes in the spring.
- f. Once bylaws are drafted, Mike will send to committee members for a review before going to Instructional Council for review.
- 5. The committee will review the International Recruitment Plan and updates at a future meeting.
- 6. At the next meeting, the committee will review the 2021-2024 Enrollment Management Plan.
