Dear Mr. Rodrigue:

Western Governors University (WGU) is delighted for the opportunity to assist with Shasta College student transfer goals. WGU's online, competency-based and mentor-supported programs fit into busy work and home schedules. The transfer partnership outlined in this letter agreement will inform and encourage your graduates and employees to earn degrees to advance their personal goals and the educational mission of Shasta College.

As a transfer partner, WGU will offer your graduates and employees a five percent (5%) tuition discount for up to four (4) academic terms. WGU will create a custom landing page to link your students and employees to WGU, and will provide print materials and articulation tables for counselors and faculty to share with students and employees interested in enrolling at WGU. While we expect Shasta College graduates and employees will be prepared for WGU's rigorous programs, as a reminder, WGU must retain sole discretion in admission decisions. Graduates and employees of Shasta College will be eligible to apply for scholarships offered through the WGU Community College Partner Scholarship fund. Scholarships are valued at up to \$2,000.00. Recipients will receive a \$500.00 tuition credit each term, renewable for up to four terms based on satisfactory academic performance.

In order to inform your students and employees of the Shasta College – WGU partnership, as we discussed, you agree to share information about the partnership and education benefits through your academic advisement and transfer counseling services, and establish a web link from the Shasta College internal web page to the WGU Community College Partner landing page (http://www.wgu.edu/community\_college\_partners?utm\_source=5054). WGU will be included in other transfer information programs scheduled by Shasta College or academic departments offering related degree programs.

These understandings serve as the basis of the Shasta College – WGU partnership and may be modified by mutual written consent or terminated by either party upon thirty (30) days prior written notice. In the unlikely event the partnership is terminated, we agree that Shasta College graduates and employees then receiving any educational benefit described in this agreement will receive the full value of that benefit towards their studies as long as they remain in good academic standing.

WGU is pleased to partner with Shasta College in providing these important benefits to Shasta College graduates and employees.
